General Description:

Selenase® solution for injection is a medicinal product which belongs to the group of the mineral supplements. Sodium selenite pentahydrate, the active substance in the solution for injection, provides a source of selenium, which is an essential trace element in nutrition to ensure that the metabolism functions efficiently.

Indications:

selenium deficiency which cannot be corrected by selenium intake from food sources.

Contraindications:

- Hypersensitivity to sodium selenite pentahydrate or to any of the excipients
- Selenosis

Adverse reactions:

Like all medicines, selenase[®] solution for injection can cause side effects, although not everybody gets them. Frequency not known (cannot be estimated from the available data): pain at the place after intramuscular administration.

Pregnancy category:

There are no data from the use of selenase® solution for injection in pregnant women. No adverse effect of sodium selenite on the pregnancy or the unborn child is expected, provided that it is used in case of proven selenium deficiency.

General Description:

Sero-Tet is a sterile solution containing tetanus immune globulin which is prepared by Cohn fractionation from plasma of individuals with high titers of antibody to the tetanus antigen and heat inactivation step in manufacturing process (60 °C, 10 hrs) is used to inactivate infectious agents such as Hepatitis B Virus, Hepatitis C Virus, Human Immunodeficiency Virus, and so on. A donor unit found to be negative to anti-HIV 1/2, anti-HCV and HBsAg are only used in preparation of Sero-Tet.

INDICATIONS:

Passive immunization against infection caused by Clostridium tetani. For IM injection only.

Adults and Children: Prophylaxis for Tetanus: Usual Dose: 250 IU.

Treatment of Tetanus: Dose should not be less than 5000 IU.

Special Precautions:

Sero-Tet should not be administered IV.

It should be administered with caution to individuals who have exhibited previous systemic allergic reactions to immune globulin. Epinephrine (0.1-0.5 mL, 1:1000) should be available for immediate treatment.

Store at 2-8°C.

General Description:

- Active DVT, PE, or a history of these conditions
- Active arterial thromboembolic disease (for example, stroke and MI), or a history of these conditions
- Known anaphylactic reaction or angioedema to conjugated estrogen Vaginal Cream
- Known liver dysfunction or disease
- Known protein C, protein S or antithrombin deficiency or other known thrombophilic disorders
- Known or suspected pregnancy.
